WOMEN TOGETHER; Stamping out sectarianism / Listening circles

COMHLAMH CONFLICT RESEARCH PROJECT

Follow up workshops are being held in Newry on 11th October, Belfast on 23rd October and Donegal on 6th November for interested groups out of the 330 across Northern Ireland and the Republic's border counties who took part in a survey exploring local and Third World conflict issues. Two more discussion fora are planned for Letterkenny and L'Derry. COST OF THE TROUBLES STUDY

The first publication from the Cost of the Troubles Study is now out, entitled *'Mapping Troubles-related deaths and deprivation in Northern Ireland'*, (80 pages A5) written by Marie Therese Fay, Mike Morrissey and Marie Smyth. This project is a two-year investigation into the experiences and effects of the troubles on people in Northern Ireland, both direct and indirect - including the impact on the general population. RESCUE TRUST Petition on UN Convention against Torture

Rescue Trust, which was established in Ireland in 1989, is a charity working to improve health care and rehabilitation for all refugees and asylum seekers in Ireland. It is currently organising a petition to the Irish government to ratify the United Nations Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment. This was signed by the Irish government in September 1992 but the Republic is almost unique in Europe in not having ratified it - which would have important repercussions. It outlaws torture, obliges relevant personnel to be educated about torture and its effects and guarantees relevant health care for

torture survivors. This is even more essential with the arrival in the Republic of around 100 asylum seekers a week. Petition forms or other information available from: Rescue Trust, Capel Chambers, 119 Capel Street, Dublin 1, Phone/Fax 01 - 872 2371.

INCORE

There have been a number of personnel changes at INCORE, the Initiative on Conflict Resolution and Ethnicity, this year. Mari Fitzduff, formerly director of the Community Relations Council, took over from John Darby as director of INCORE in April. Guus Meijer, who had been training director for two and a half years, has returned to London to join Conciliation Resources. Gillian Robinson has taken on the post of research director. Meanwhile 120 delegates attended the INCORE-related third Ethnic Studies Network conference in June (a report is included in the August issue of the Ethnic Studies Network *Bulletin*). Comhlámh, the Irish Association of Returned Development Workers, works to promote global development through education and action and has a variety of working groups within this area. It is open to anyone interested to participate. Subscriptions include *FOCUS on Ireland and the Wider World*, *NODE News*, and *Comhlámh News*; subs are £20 full-time waged, £12 part-time waged, £6 unwaged. *FOCUS* is available by subscription separately (6 issues over 2 years) at £8; back issues are available at £1 a copy.
